Cases may not be tried in the order listed on the trial calendar.

Unless Georgia law provides otherwise, **all pretrial motions should be filed by November 5, 2025.** *See* USCR 31.1. A rule nisi should be attached to each motion. Exceptions shall be made upon a showing of good cause.
